

# Prohibited and Restricted Goods Guide

#### **Purpose**

This Prohibited and Restricted Goods Guide describes the contents and packaging of articles that cannot be accepted by Star Track Express Pty Limited (StarTrack), excluding the StarTrack Courier Service. For details about the StarTrack Courier Service please speak to your Account Manager.

#### How to read this guide

#### Terms and conditions of service

Terms and conditions are contained in the Star Track Express Pty Limited Terms and Conditions, available on <u>our website</u>. When consigning Goods with StarTrack, it's your responsibility to understand and comply with your legal obligations in relation to Chain of Responsibility. Visit <u>our website</u> for more information. You must also comply with all applicable Laws and any reasonable directions given by us when consigning Goods with us. It is your responsibility to select an appropriate and compliant Service for the delivery of your Goods in accordance with any reasonable directions given by us. Should you fail to meet the requirements of this Guide we may be unable to deliver the Goods. Additional Charges may apply to various categories of Goods. You may also find it useful to refer to the Parcel and Freight Preparation Guide to help you prepare your consignments for delivery.

#### Note on dangerous goods

Dangerous Goods (as defined in the <u>StarTrack Terms and Conditions</u>) may only be consigned with our prior consent, and subject to special restrictions and obligations. Some examples of Dangerous Goods include aerosols, lithium batteries and flammable liquids. Consignments containing Dangerous Goods will incur an additional transit day to the delivery time estimates provided by us. Additional Charges apply to the delivery of Dangerous Goods. For information about the consignment of Dangerous Goods (and the associated Additional Charges), please refer to the <u>StarTrack Terms and Conditions</u>, the <u>Dangerous Goods Guide</u> and the document entitled "Additional Charges" which is generally appended to your Pricing Schedule and which can be found here.

### Note on manually handled and oversize goods

Oversize Goods (as defined in the <u>StarTrack Terms and Conditions</u>) may only be consigned with our prior consent. Consignments containing Oversize Goods or requiring manual handling will incur an additional transit day to the delivery time estimates provided by us. For information about consigning Oversize Goods or Goods requiring manual handling, please refer to the <u>StarTrack Terms and Conditions</u> and the document entitled "Additional Charges" which is generally appended to your Pricing Schedule and which can be <u>found here</u>.

Manufactured metal items that can be cartonised, such as door handles, cups, and cutlery, and which are not otherwise described as Prohibited or Restricted Goods may be accepted. Motorbikes and automobiles Disassembled parts which are not otherwise described as Prohibited or Restricted Goods may be accepted if they are packaged in accordance with Table 1.					
Refrigerated/perishable items (for human consumption) StarTrack prohibits Goods in these categories from all StarTrack Services as StarTrack operates an ambient network.					
Sandbags and similar items (filled) These include, but are not limited to filled garden soil bags, fertiliser bags, pool salt bags and rice bags.					
Tyres, including motorbike tyres (not in cartons)					
Wire spools or drums on skids or pallets StarTrack prohibits Goods in these categories from all StarTrack Services if non-compliant with the packaging requirements outlined in Table 1.
